# **Data Privacy Statement**

#### General

This privacy policy informs the user of the website of the Serfaus-Fiss-Ladis holiday region about the type, scope and purposes of collection and use of personal data by Serfaus-Fiss-Ladis Tourist Board (hereinafter referred to as the operator).

Personal data (e.g. name, e-mail address, telephone number) is processed and transferred by the operator only in a legal manner - in particular for fulfilment of contractual duties, on account of overriding justified interests of the operator or on the basis of consent from the user.

The legality of the data processing is based on the Austrian Data Protection Act as well as Regulation (EU) 2016/679 (GDPR). The legal basis is stated specifically in each case for the processing outlined below.

The operator of the website is required to inform each data subject within 72 hours if this homepage is hacked and its sensitive data is stolen. This data theft must be notified not only to the data subject but also to the data protection authority within the above-mentioned period.

# Presentation on the website

Each time this website is accessed the operator stores the following data: requested file, date/time, transferred data quantities, report on successful access, browser type/version, operating system and IP address. By visiting this website the user grants definitive consent in accordance with Art. 6 (1) a GDPR for short-term storage of the IP address of the terminal device. This is necessary for provision of the website. The user's IP address will be deleted after the use of the website.

The operator uses the above-mentioned data only for statistical purposes in connection with their services.

# **ROOM INQUIRIES AND BOOKINGS**

When you make contact with the operator the following data of the user is stored in order to process the enquiry and in case subsequent enquiries arise: Salutation, first name and surname, postal address, e-mail address, telephone number as well as data relating to the enquiry.

Personal data relating to your request for accommodation is collected only to the necessary extent, stored for a period of 48 Month and made available during this period to the accommodation establishments of the Serfaus-Fiss-Ladis holiday region so that they can prepare an offer for your holiday.

The data provided by the user shall be processed and used by the operator only insofar as it is necessary for processing of the enquiry and/or rendering the requested service.

We will never sell or pass on the data we collect to other third parties for any other reason. Your trust matters to us. Data processing is required in accordance with Art. 6 (1) b GDPR for fulfilment of the contract or for carrying out precontractual measures

For the protection of your data, we remain responsible for the use of a data processor. We use data processors outside the European Union only if there is a European Commission adequacy decision for the third country concerned or if there are appropriate guarantees or binding internal data protection rules with the data processor.

# Safeguarding your personal data

Personal data consists of information relating to your identity such as your name, address, telephone number and e-mail address. We protect your personal data against unauthorized access, use or disclosure. We ensure that personal information you provide on the server is stored at a controlled secure location which prevents unauthorized access and disclosure.

Serfaus-Fiss-Ladis Tourist Board only allows accommodation providers who have their registered office in the Serfaus-Fiss-Ladis holiday region to access the data. Companies that are eligible to submit offers in accordance with your requirements and specifications are given access to your personal data. Insofar as we are required to do so by law or by a court order, we shall only disclose your data on to authorized state institutions and authorities.

# Registration

Registration is not required for the use of this website. After registering on this website the user will automatically receive information and assistance for a planned stay in the Serfaus-Fiss-Ladis region.

By registering the user grants definitive consent in accordance with Art. 6 (1) a GDPR to the effect that his data entered (first name and surname, address, telephone number, e-mail address and optionally credit card data) may be stored by the operator and used in order to provide additional content.

# Webshop

When you order something from the web shop on this website, personal data of the user, in particular first name, family name, address, email address and birth date, are collected and processed. This data is necessary for processing and delivering your order and is required in accordance with § 8 (3) fig. 4 GDPR and Art. 6 (1) b GDPR for fulfillment of the contract.

Unless this is required for contract processing, the data of the user shall not be passed to third parties. Disclosure of the date to suppliers of the operator and business partners, e.g. the Ski School Serfaus/ Ski School Fiss-Ladis, is required for contract processing. Furthermore, disclosure to a transportation business, debt collection agency or lawyer may be necessary.

# **Transfer to partner companies**

Within the framework of partnerships data is transferred to Fisser Bergbahnen GmbH and Seilbahn Komperdell GmbH. The above companies may use this data to program ski passes as well as the Super. Sommer. Card. The companies delete the data after 3 years. If you revoke your consent the companies are required to delete all data immediately.

# Social media plug-ins

The operator uses embedded social media plug-ins (interfaces to social networks) on the website. When the website is visited the system automatically creates a connection with the respective social network on the basis of the integrated plug-ins and transfers the data (IP address, website visit etc.).

#### **Cookies**

#### **GOOGLE ANALYTICS**

The information about your use of this website generated by the cookie is normally sent to a Google server in the USA and stored there. # Activation of interest-based advertising with help of 'retargeting'

This website uses 'retargeting tags'. A 'retargeting tag' is a JavaScript element that is placed in the source code of the website. ## **GOOGLE Remarketing**

#### **HOTJAR**

## Right to information:

#### Right to rectification:

If we process incomplete or incorrect personal information from you, you can request their correction or completion at any time (Art. 16 GDPR).

#### Right to erasure:

If your personal data are processes by us unlawfully, you can demand the deletion of your personal data from us. There may well be reasons opposing an immediate deletion.

# Right to restrict processing:

You have the right to restrict the processing of your data. If you challenge the accuracy of the data or legal basis of its processing, you may request that the processing of your data be restricted for the duration of the audit. If the processing of your personal information is unlawful, but you need the data for asserting / enforcing legal claims, and do not wish it to be deleted, you can object to the further processing of the data.

## Right to data portability:

You have the right to demand the publication of the data provided by you in machine-readable form, provided that processing takes place on the basis of a consent or a contract.

## Right to object:

As long as the legality of specific data processing is based on consent from the user, the user may revoke the consent at any time (even partially) by sending an e-mail to datenschutz@serfaus-fiss-ladis.at. This may affect the functionality of the content offered on this website. (Art. 21 GDPR)

#### Right of appeal:
